General Information, Rules, and Regulations



POOL DATES AND HOURS:

The pool opens on the Saturday before Memorial Day and will be in operation, weather permitting, through Labor Day. Between Memorial Day and the end of the school year for CASD, the pool will be closed on weekdays.

Pool Hours :

Every Day 11 am — 7pm

Pool Café Hours:

11 am—5 pm daily

Hours may be extended during hot weather at the discretion of the Pool Director. *No one may enter the pool unless the Pool Director or the lifeguards are present and on duty. The Pool Director may establish brief periods of adult-only swim during certain days, normally weekends or holidays.

Registration:

All members must register at the cafe each time they use the pool. Please fill in all necessary information. Guest fees will be billed to the member's account which must be listed along with the information requested for each guest on the registration form. A babysitter or nanny of a member's child(ren) may accompany the child(ren) at no cost. This person must be noted as such at registration.

Children: Supervision

Parents are accountable for the behavior of their children at all times and must accompany all children under the age of 12. Please instruct your children to obey the rules and regulations for using the pool and surrounding areas. Please do not ask the lifeguards or the Pool Director to watch your children. They are responsible for the safety and well-being of all the people enjoying the swimming venue and should not be asked to baby sit while working. The shower rooms are not play areas, and parents should instruct their children accordingly. Children will be allowed beyond the 4 foot depth only after passing a deep water test administered by the pool personnel (similar to the Red Cross test); the only exception to this rule is when a child is under direct adult supervision. An adult in the water must accompany children wearing arm floaties.

Guests:

Resident guests are those persons residing within a 15 mile radius of the Club. They are permitted to use the pool **4 times** within the season. There is no limit on the use of the pool by non-resident guests or guests under age 18. Guest registration, conduct, and fees are the responsibility of the hosting members. Members must accompany their guest during their visit. Guest fees shall be paid for persons 2 years and older. Guests of Equity members must be noted as such upon registration. Adult babysitters are considered part of the members' family for the duration of their stay at the pool and will not be charged a guest fees.

Safety Rules:

Games and activities must be played in such a manner as to not annoy or endanger others. Please avoid running, pushing, wrestling, dunking, or other rough play. Inner tubes, air mattresses, rubber or plastic balls or games that involve throwing and retrieving objects in the pool may only be used in the non-diving areas of the pool and with the permission of the lifeguard or Pool Director. This permission may be revoked at any time if the pool becomes crowded or if the activity bothers other patrons. Any other items may not be used or thrown in the pool. The lifeguards or the Pool Director may suspend the swimming privileges for anyone who disregards the rules or is perceived to be endangering others.



Wading Pool:

Use of the wading pool is restricted to children ages 6 and under. **ALL children using the wading pool must be under DIRECT SUPERVISION of an adult or nanny/babysitter.**

Café Area:

Open daily for your enjoyment. **Food & Beverages must be purchased at the Club, outside alcohol brought on to the premise is prohibited.** These guidelines will be strictly enforced.

Swimming Lessons:

Persons interested in individual or group lessons should contact the Pool Director. Lessons are held Monday thru Friday mornings prior to the pool's opening hours. Swimming lessons are conducted under the direction of an American Red Cross Certified Water Safety Instructor. All levels of the American Red Cross "Learn To Swim" program are offered weekly from the first full week after school ends to the last full week in July. The cost is \$35 per child per week for club members, and \$40 per week per child for non-members. Club members will have preferred access to the "learn to swim" program and will be guaranteed access throughout the season provided that they book lessons a minimum of 1 week in advance.

Kids' Night:

Kids' Night at the pool is a great opportunity for the kids to enjoy an evening of fun. At this event, there are games, swimming, and pizza. Kids' Night is open to school age children through grade 8. A fee of \$5 per child pays for the food and guards. Dates for Kids' Nights are to be determined and will be announced in the Club News and posted at the pool.

Pool Rental:

Members:

Members of the Chambersburg Country Club may rent the pool for special occasions for a fee of \$125 for up to 3 hours by contacting the Pool Director or Club Event Coordinator. Additional hours will be charged at the rate of \$100 per hour. Scheduling will be at the Pool Director's discretion. A fee of \$10 per hour for each lifeguard will also be charged to the member.

Non-Members:

Non-members may rent the pool for special occasions for a fee of \$225 for up to 3 hours by contacting the Pool Director or the Special Event Coordinator. Additional hours will be charged at the fee of \$150 per hour. Scheduling will be at the Pool Director's discretion. A fee of \$12 per hour for each lifeguard will also be charged to the non-member hosting the event.

Equity Members:

Equity members will not be charged a pool rental fee if their usage of the pool for a private function falls within their allotted 4 times per year facility usage for personal or business reasons.

Swimming Pool Rental Fees:

Lifeguard Services per guard per hour	\$10
Non-Member Special Occasion	\$225
Additional hours (per hour)	\$150
Lifeguard Services per guard per hour	\$12

NOTE: Sales Tax is added for all rentals and services in accordance with Pennsylvania State Law.
